### **RS13 MRF Regional Site**

Metering for MRF Heat

- Cabs are not tied into existing monitoring
- Cost \$12,000 to add monitor to cabs to be reviewed and discussed at a later date

### **MRF Sign Off List**

- SNC Lavalin are required to ensure all warranties, certificates, manuals, etc on the elevator, dust collection system and all other work carried out on the MRF are handed over to CRSB.

#### **Regional Site - Landfill Expansion Cell #2 – Adams Construction**

- Roads will be fixed in the Spring 2017. A \$20,000 holdback is in place on this work. - Final Claim released
