Clearing and Grubbing TS1 (Professional Grading Ltd.)

- All clearing has been completed

- Grubbing for Terra Nova, Indian Bay, Fogo, NWI completed
- Buchan's, Point Leamington and Gander Bay to be completed

Geotechnical:

Well Drilling TS03:

Site Buildings TS02:

- Drawings 100% complete and sent for approval to tender

Civil Works TS05:

- Operation of site responsibility of Fogo Island Regional Council

Fogo Island Interim Transfer Station:

- Funding approved is \$436,000
- Approval received from DMA for operating cost subsidy
- Approval received from DMA to construct temporary facility
- Waiting on acceptance to costs from Fogo Island Regional Verbal agreement received; a letter is on the way.
- Approval to award transfer trailers contract granted by C. Grandy, Municipal Affairs
- Award trucking contract (low bidder has agreed to accept the contract at the tendered price)
- Civil Works design 90% complete. A copy to be sent to C. Grandy for review.
- Have to design and tender civil works
- Have to tender for BKHO
- Have to tender for scales

Twillingate Interim Waste Disposal Study:
