Update on WRWM Tip Fee

-The Board is in agreement to moving forward on this matter and looking forward to reviewing the terms of reference that will be forth coming from the province (working group).

New Maintenance Garage and Wash Bay - Ground work complete; foundation complete. Building should be delivered on site December 18th.

Update –Collection Trucks

Another delay on the delivery of the first 2 trucks ordered. Second 2 trucks are still scheduled to be delivered June /July 2024. CRSB is till waiting on requested financial assistance from the Province under the Gas Tax program.

Review the Options for improvements in the Blue Bag Program

- CRSB set up a booth in the MNL tradeshow in St. John's with new displays and information on Blue Bag Recycling, this included what is acceptable and not acceptable in the blue bag. CRSB has been added to the agenda of the PMA conference in Gander and is requesting the opportunity to present at the MNL Symposium in Gander.

Fleet Management Review – The consensus of the Board is to move forward with the report presented by CAO on CNWM Fleet Management

Letter from the Town of New Wes Valley was received regarding the collection fees increase for 2024. It was reviewed by the Board and CAO will respond.

Christmas bonus - Staff and Management
